WHAT IS THIS PRODUCT?

Type:

The fund is a sub-fund of Summit Mutual Funds plc, an open ended umbrella investment company with variable capital with segregated liability between its sub-funds and is established as an undertaking for collective investments in transferable securities ("UCITS").

Term:

This product is not subject to any fixed term. The PRIIPs manufacturer may not terminate the fund unilaterally. The fund may however be terminated at any time in line with the constitutional documents of the company.

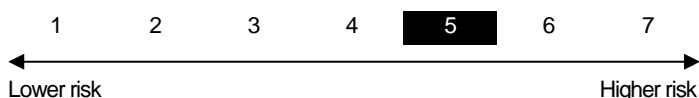
Objectives:

- The fund aims to deliver steady capital growth over the long term.
- The fund seeks to achieve its investment objective by investing in listed equities (shares) of international companies with large market capitalisations operating in different geographical regions and business sectors.
- Whilst the Investment Manager has discretion in selecting appropriate investments for the fund that conform to the stated investment policy of the fund, this fund is passively managed in reference to the Dow Jones Global Titans 50 Index (the "Index"), an index comprised of 50 of the largest (by market capitalisation) multinational companies traded on major exchanges.
- The fund does not replicate the Index, but the fund's portfolio principally comprises all constituents of the Index with a weighting of above 1.25% of the Index and the weightings applied to these constituents within the Index are typically mirrored at fund level.
- The fund's portfolio is also rebalanced periodically to ensure that the fund holds all constituents of the Index with a weighting of above 1.25% of the Index. Accordingly, the individual holdings and corresponding weightings of the fund's portfolio do not deviate to a significant degree from those of the Index. However, the investment manager uses discretion as to whether or not to hold constituents of the Index with a weighting of below 1.25%, based on a value assessment of these securities.
- Further, the fund shall only acquire shares of companies with a market capitalisation in excess of US10 billion. As the fund invests in very large companies this can result in the return being subject to higher levels of fluctuations in share price than in more broadly based equity and mixed funds. An investment in this fund should not constitute a substantial proportion of an investment portfolio.
- The fund may from time to time invest in bonds (loans that pay a fixed or variable rate of interest) that have a credit rating by Moody's Investor Services of higher than 'A3' or Standard & Poors of higher than A-.
- The fund may invest in derivatives (complex financial instruments) such as index future contracts, forwards, options and swaps rather than investing directly in the underlying security. The derivatives return is linked to movements in the underlying asset.
- Any income the fund generates will be reinvested to grow the value of your investment.
- You can buy and sell shares in the fund on any business day (days that the banks are normally open for business) in Ireland.

Intended Retail Investor:

The fund is intended for retail investors who have obtained appropriate investment advice and have the ability to bear losses up to the amount invested in the fund. Investment in the fund may be suitable for investors with a long-term investment horizon. The depositary for the fund is Northern Trust Fiduciary Services (Ireland) Limited. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as class 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of the fund to pay you.

Recommended minimum holding period: 5 years

The fund has no minimum holding period however this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years. The recommended holding period of the fund assumes the fund being the sole or majority holding of the investor. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The Fund is not intended for short term speculation purposes.
